

Special recognition goes to member Niña Henderson and CEO Taylor Oldroyd for their leadership roles.

In addition, both Taylor Oldroyd and Jessica Gauthier, our Director of Communications and PR, were invited to participate in a City Hall focus group on housing needs—a testament to ARBOR's growing reputation as a trusted voice in local housing conversations.

In partnership with the City of Arlington, ARBOR played a pivotal role in planning their Homeownership Fair, which became the city's most attended event to date—a clear indication of our community impact.

Thanks to our successful grant writing efforts, we secured funding for projects and initiatives that would not have been possible otherwise, ensuring that ARBOR remains innovative and forward-thinking.




Immediate Past-President

The CSF is proud to contribute to our community and looks forward to continuing these impactful initiatives in the coming year.









Each dollar is carefully allocated by the Budget & Finance Committee and reviewed monthly by the Executive Committees and Board of Directors to ensure full accountability. Thanks to our **conservative budgeting approach**, we successfully managed unexpected expenses, including flood repairs and legal challenges.






Our commitment to financial transparency is reaffirmed by our annual audit, where we once again received the highest possible rating—an **Unmodified Opinion**.



GOVERNMENT AFFAIRS

The GAC had a highly impactful year, supporting key candidates like Sheriff Bill Waybourn and contributing to the success of defeating an incumbent constable seat. Our influence extended to significant local policy updates, including:

- UDC (Unified Development Code) Updates: Successfully advocated for the removal of landscape standards enforcement on private property, protecting property rights.
- Arlington Tree Preservation Ordinance: Provided input to balance conservation efforts with property ownership rights.
- Form-Based Code Pilot Zone: Supported the introduction of this new zoning approach in Downtown Arlington.
- Universal Building Design Standards: Engaged in discussions to shape equitable building standards.





The GAC's work also had statewide and national reach. Chair Dixon Holman was named Chair of Texas REALTORS® Public Policy Oversight Committee, and 2025 GAC Chair Terrance Hood-Veal was appointed to the TR Political Involvement Committee. We hosted and met with Congressmen Ellzey and Williams, advocating in Washington D.C. Additionally, CEO Taylor Oldroyd represented NAR on the Smart Growth Advisory Board and Sustainability Advisory Group.

Looking ahead to 2025, key advocacy priorities include housing during the FIFA Tournament, building design standards, comprehensive planning proposals, the 89th Legislative Session, and preparing for municipal elections. ARBOR remains committed to partnering with elected officials and community leaders to strengthen the voice of real estate and protect private property rights.

MLS UPDATES: A YEAR OF INNOVATION AND TRANSITION

The big news in the MLS world is the retirement of NTREIS CEO John Holley after 20 years of dedicated service. We thank John for his incredible contributions to NTREIS and the industry, and we wish him all the best in this exciting new chapter!

In 2024, ARBOR's MLS Committee and User Group collaborated closely with NTREIS to enhance Matrix 12 and introduce new tools for REALTORS®.

Key 2024 Accomplishments:

- New Realist Dashboard: Added valuable industry insights.
- Restb.ai Integration: Implemented Al-driven photo tagging and descriptions.
- Roster Procedure Updates: Adjusted processes to align with new AMS systems.
- Paragon Connect: Launched an enhanced search interface.
- Clareity Security: Strengthened onboarding and registration with improved security protocols.
- New Compensation Rules: Updated governance documents, data feeds, and system displays in Matrix and Paragon.
- RESO 2.0 Certification: Achieved certification for compliance with the latest data standards.
- Branding Center Launch: Introduced customizable branding for Matrix, OneHome, and MLS Touch.

Looking Ahead to 2025:

Exciting updates and partnerships are on the horizon for the new year:

- New Matrix Add/Edit Features: Scheduled for January.
- Paragon Listing Management: Open testing in January, with a release in early February.
- Data Shares Expansion:
 - FMLS (Atlanta, Georgia): Intra-Matrix listing views (January).
 - Omni MLS (Mexico and Central America): Intra-Matrix listing views (to be scheduled).
 - Houston: Full data share launching in January.
- Clareity SSO Multi-Factor Authentication: Strengthened security features (January/February).
- Listing Data Checker Update: Scheduled for January 14.
- Rental Beast Integration: In development, with an expected release in April.
- Continued Strategic Planning Initiatives: A focus on optimizing MLS services to meet evolving member needs.

These improvements reflect ARBOR's commitment to providing cutting-edge MLS tools and maintaining strong partnerships that empower REALTORS® to succeed.
